Payment in full: This payment, due on or before July 1, 2008, may be made directly to the school by check or cash. Please note that the discounted tuition option has been discontinued.

Payment Using FACTS: If you are not currently enrolled, you must enroll in FACTS via the eCashier link on the CES web site, click on Parent tab. If you are currently enrolled for Automatic Bank Payments, you do not have to reenroll, just sign the enclosed FACTS reenrollment form. If you wish to reenroll using a credit card, you must contact FACTS to reauthorize payments for the new school year.

Automatic Bank Payments through your checking or savings account can be made on either the 5th or 20th of the month. annual FACTS enrollment fee and CES processing fee will apply.

10 months July-April (FACTS fee \$41/family, CES fee \$150/student)

2 payments due July 1st and Nov. 1st (FACTS fee \$15/family, CES fee \$30/student)

MasterCard, AMEX, or Discover. Automatically scheduled monthly payments through your credit card. If you select this option, in addition to the annual non-refundable FACTS enrollment fee and CES processing fee, each payment will also incur a credit card convenience fee. Please print the Credit Card Authorization form from the CES web site and follow instructions.

10 months July-April (2.5% credit card fee, FACTS fee of \$41/family, CES fee of \$150/student)

2 payments due July 1st and Nov. 1st (2.5% credit card fee, FACTS fee \$15/family, CES fee \$30/student)

1 payment due July 1st (2.5% credit card fee, FACTS fee of \$10/family, no CES fee)

Note that if you choose to use one of the FACTS options to pay your tuition, you have a choice of the 5th of the month or the 20th of the month. Please select the 20th of the preceding month or the 5th of the month due when scheduling payments for all options. The fees from FACTS will be charged with your first payment and the Business Office will input tuition due per the Schedule of Fees attached.
